"A Meeting of the Federation Council of All India State Bank of India Staff Federation (AISBISF) was held on 12<sup>th</sup> November 2016 at Indore under the Presidentship of Com.V.V.S.R. Sarma, our Federation President, to consider the suggestions received from Affiliates/Units/Members and to formulate/finalise the Charter of Demands for 11<sup>th</sup> Bipartite Wage Settlement and also to discuss on other issues relating to the organisation as per the Agenda.


