IMPLEMENTATION OF 11th WAGE REVISION SETTLEMENT COLLECTION OF SPECIAL LEVY

Our patience and perseverance have ultimately paid rich dividends. We are happy to inform that the historic Eleventh Bipartite Wage Settlement has been signed on 11.11.2020 in the Banking Industry. The anxiety and waiting of lacs of Bank employees all over the country is over with the successful conclusion of Bipartite Settlement on Wage Revision.

Every time, on the conclusion of Bipartite Settlement and consequent increase in Wages and Allowances, we contribute a portion of arrears in the form of Levy to strengthen our beloved organizations i.e., Union, Federation and NCBE.

You are also aware that we have built up 'Com. Y. Tharak Nath Memorial Fund' from which we are taking up welfare activities like financial assistance to the needy persons including our members of the Union and the society at large. We have also enhanced the scope of the scheme and taken up more welfare activities like grant of scholarships to meritorious children of our members.

The Working Committee of the Union in its Meeting held on 16^{th} and 17^{th} November 2020 at Hyderabad has unanimously passed a resolution to collect Special Levy @ 3% of Net Arrears on account of 11^{th} Bipartite Wage Revision from all our Members in Hyderabad Circle.
