IMPORTANT DECISIONS TAKEN AT THE 25TH GENERAL BODY MEETING AT WARANGAL ON 25TH & 26TH JUNE 2022

The Delegate Session of the 25th General Body was held on 25th and 26th June 2022 at University Arts & Science College, Warangal.

In the Delegate Session, the Report of the General Secretary submitted on behalf of the Working Committee along with Audited Statements of Accounts for the years 2019, 2020 & 2021 were unanimously approved by the General Body after keen participation of Delegates in the debate on report.

Thereafter, the Amendments to Bye-Laws and Rules of the Union, as recommended by the Working Committee were approved unanimously. Resolutions on various topics of concern to the members, which arised out of General Secretary Report and otherwise were unanimously approved by the General Body.

The important decisions taken in the Delegate Session are as under:

AMENDMENTS TO BYE-LAWS

(i) **ENHANCEMENT OF SUBSCRIPTION:** Keeping in view the escalating cost over a period of 13 years since last enhancement of subscription in the year 2009, the General Body unanimously approved the Amendment to Bye Law 4(i)(a) of the Bye-Laws and Rules of the Union, for enhancement of monthly subscription as follows:

MEMBERSHIP ADMISSION FEE	:	RS. 100/-
CLERICAL STAFF	:	RS. 160/- p.m
SUBORDINATE STAFF	:	RS. 80/- p.m
SUPERVISING STAFF	:	RS. 120/- p.m

The new rates of subscription would come into effect from the Month of July 2022. Accordingly, we are attaching a format of Check-off form for use at your Unit.

We advise all our Local Secretaries to obtain fresh Check-off form from all members of the Unit. One copy of the Check-off form shall be sent to the Head Quarters for effecting the monthly deduction, the second copy shall be given to the Office/Branch Manager and third copy shall be retained at the Local Unit for its record.

We request all our Local Secretaries to attend to this work immediately, in any case well before 20th July 2022. **THIS IS IMPORTANT.**

(ii) In order to meet the needs of the Organisation and also in tune with the new changes made in the administrative structure of the Bank in the Circle viz., creation of Cyberabad R.O, necessary amendments to the Bye-Laws 8(a)(ii), 8(a)(vi) for creation additional positions were unanimously approved by the General Body along with amendments relating to finances of the Union.


(iii) **BENEVOLENT FUND**: Members are aware that on the unfortunate death of a member, Union has been paying Rs. 30,000/- from Benevolent Fund to the family members of the deceased. It was unanimously approved in the General Body to enhance the quantum of Benevolent Fund to Rs. 40,000/-.

(iv) **NEXT GENERAL BODY MEETING OF THE UNION**: In the Working Committee Meeting of the Union conducted after the election of the new body, the proposal of Com. D. Prasad, Deputy General Secretary, Secunderabad Regional Office, Com. D. Udaya Bhaskar, Deputy General Secretary, Hyderabad Regional Office and Com. B. Sanjay Singh Chauhan, Deputy General Secretary, Cyberabad Regional Office to host next General Body Meeting at Twin Cities of Hyderabad & Secunderabad was unanimously approved by the House.

We are confident that all our Local Secretaries would extend their whole-hearted co-operation and support for effective functioning of the Union at all levels.
