Due to the persistent efforts of our union the Inter-Module transfers could be successfully completed benefitting the majority of the members who have been waiting to be transferred near to their native places. The issue pertaining the Inter-Circle transfers (ICT) has been a persistent issue ever since the merger of associate banks in 2017 and with consistent and constant efforts of our Union/Federation, all such eligible members have been bestowed with their desired Inter-Circle Transfer by 2024 paving the way for their total satisfaction.

We are also happy to inform that cashless treatment facilities are available for our members in majority of the Corporate Hospitals located in Hyderabad Centre. Similar facility at big centers in other modules is also required and our efforts are underway to extend this benefit to all major towns in addition to Metro Centres.

Due to Union's efforts, the demonetization period overtime payment was made to all clerical staff and sub-staff working in SBI before 2017 and in respect of the clerical staff of e-SBH whose login data was available had also beenmade. Overtime payment for the demonetization in respect of the remaining members i.e., e-AB Sub-Staff & Armed Guards and some of the other e-ABs, is being constantly and continuously pursued by our Union. Negotiations are ongoing to ensure similar payments for the leftover members, which will be implemented soon. Since the 2017 merger, we have united as one and demonstrated that the union will not rest until the benefits due are delivered to every member.

As the Government moves toward privatizing public sector banks, modifying labour laws & Service Conditions, we face challenges that can adversely affect employees, customers, and the nation.
